## About the Scholarship

Janet Law, a former student at The Learning Connexion, was in her first year of the Advanced Diploma programme when she passed away in November 2010. Creativity made a huge difference in Janet's life. Janet's friends and family wanted to honour her by supporting a scholarship which would offer another student the opportunity to engage with The Learning Connexion.

The aim of the Janet Law Scholarship, which is administered by the Janet Law Charitable Trust, is to provide funding for an art student at The Learning Connexion. The Janet Law Scholarship is an annual grant given to a current student, ideally enrolling in the Advanced Diploma.

## What does the Scholarship Cover?

The Janet Law Scholarship, which is administered by the Janet Law Charitable Trust, is awarded to cover full or part tuition fees for one student annually.

## Ideal Applicants

- A Diploma (Level 6) student wishing to progress to the Advanced Diploma (Level 7) who has demonstrated, or can demonstrate in an application, a clear idea of how their work deals with and/or how it might be viewed either in a cultural, social or political context; and/or
- Someone whose art may exhibit a cultural theme which may include cross-cultural heritage; and/or
- Someone who, through circumstances, may not have had the opportunity to study and develop their art until later in life.

## Entry Requirements

- Successful applicants must be eligible for enrolment, see admission requirements for more details
- Applicants must be 16 years or older at the time of enrolment
- Scholarships must be taken up within one year of being granted
- Scholarships are open to permanent residents of New Zealand who meet Ministry of Education funding criteria

## How to apply

Fill out and submit the following in our online application form.

- Read the rules and conditions outlined in this document
- Applicants are to submit three recent works, in any media, that deal with **'Cultural, social or political issues'**
- Answer the following questions in relation to each image submitted:
  - » How does this work relate to your application statement?
  - » What concepts were explored in the making of this work, i.e. What influenced it?
  - » What processes were used to create the work?
  - » If you were to revisit this work, what changes would you make and why?
- Submit a statement of 200 words or less outlining how your work relates to the given theme
- Our scholarship forms have been expanded to allow applicants to provide additional evidence in the form of three supporting images per submission, which may include (but are not limited to) developmental drawings or sketches, trial/sample works that have relevance to the finished piece or images showing stages of progression through the work. While these images are not required they do add merit to the submission and will be considered as part of your application

**Please note: As the application is through an online form, we recommend applicants prepare the information above in a text document prior to submission in case of any complications. Images of your work must be available digitally, each sized 1MB or less.**

## Conditions

- The Janet Law Scholarship can be used for the following programmes:
  - » Diploma of Art and Creativity, Advanced (Level 7)
- Submissions must be your own original work
- By applying for the scholarship each applicant warrants that their entry does not infringe upon or violate the rights of any third party
- It is permissible to submit material that has been used in other contexts (such as for an exam or exhibition)
- The Learning Connexion Ltd (hereinafter TLC) may make use of the work in submissions for promotional purposes without compensation to the artist and without any requirement to seek approval for such use
- Scholarships must be taken up within one year of being granted
- Scholarships are open to permanent residents of New Zealand who meet Ministry of Education funding criteria
- To be eligible, submissions must be received by the due date. Late submissions will not be accepted
- Submissions will be assessed on merit and awards will be made at the discretion of the managing director whose decision will be final
- Scholarships are not redeemable for cash
- Should you be granted a scholarship, it does not guarantee any further scholarships or awards for continued study at TLC
- Scholarships may be taken up either by enrolling for distance delivery or by studying on-site at our Taita Campus
- Successful applicants will be advised by email by the end of the year in which they apply
